The Village Council of the Village of Saranac will hold a rescheduled regular meeting and public hearing on February 15, 2021 at 7:00 p.m. This meeting will only be held electronically pursuant to the Open Meetings Act. The purpose of the public hearing is to consider the adoption of the budget for the 2021-2022 fiscal year as set forth in this notice. The Village Council may also consider any business to come before it as permitted by law.

Pursuant to the Open Meetings Act, 1976 PA 267, and the Budget Hearings of Local Governments Act, 1963 (2nd Ex. Sess.) PA 43, the Village gives notice of the following:

1. **Reason for Electronic Meeting.** The Village Council is holding the meeting by electronic means due to capacity restrictions and social distancing requirements currently in effect under orders issued by the Michigan Department of Health and Human Services.
