VILLAGE OF SARANAC REGULAR MEETING MINUTES April 11, 2016

The Saranac Village Council Regular Meeting was called to order by President Darby at 7:00 p.m. at the Saranac Municipal Building, 27 N. Bridge Street.

The meeting was opened with the Pledge of Allegiance.

Motion was made by Whorley, supported Mackey, to approve the Regular Agenda. All yeas.

Public Comments

Garrett Hardman of BSA Troop 71 presented his idea for an Eagle Scout project. He would like to remove the graffiti from the Division Street bridge and paint a mural in its place. Hardman had cellphone pictures of the graffiti. DPW Simmons stated that he did some research and discovered that the cement on the bridge cannot be painted, per MDOT regulations.

Doll stated that Hardman would be open to suggestions from council, for an alternate Eagle Scout project. Klutman mentioned an improved canoe launch area. Mackey suggested signage near the depot, listing area businesses. DPW Simmons brought up the idea of placing a "carving board" at Scheid Park, similar to the one at Bertha Brock Park.

Hardman has until 2018 to complete his project, but is anxious to begin as soon as possible. He provided DPW Simmons with his contact information so they could further discuss potential projects.

Motion was made by Mackey, supported by Mulnix, to accept the minutes of the March 14, 2016 Regular Meeting. All yeas.

Motion was made by Klutman, supported by Simmons, to approve the Treasurer's Report of March 31, 2016. All yeas.

Various Accounts Payable items were reviewed.

Motion was made by Klutman, supported by Doll, to approve the Accounts Payable of April 11, 2016, in the amount of \$63,331.98.

Roll call vote: yeas – Doll, Klutman, Mackey, Mulnix, Simmons, Whorley, Darby; nays – none; absent – none.

Council members discussed recommendations from Village Attorney, James Doezema, relative to confirming and reestablishing speed limits within the Village.

Council reviewed a proposed resolution to adopt Ordinance No. 99, an ordinance repealing Section 26-2 (the Uniform Traffic Code) of the Village Code of Ordinances.

Council reviewed proposed Ordinance No. 99.

Mackey suggested that law enforcement opinion be sought regarding citations being written strictly under the MVC.

DPW Simmons stated that in his position of Public Works Director and Street Administrator, he has reviewed streets, speed limits and traffic throughout the Village. Based upon his investigation, it is his opinion that the speed limits in the Village should remain as they have been over the past number of decades.

Council reviewed a proposed resolution to confirm and reestablish speed limits for the Village of Saranac.

Motion was made by Doll, supported by Mulnix, to approve as presented, the Resolution to Adopt Ordinance No. 99, an Ordinance repealing Section 26-2 of the Village Code of Ordinances.

Motion was made by Klutman, supported by Whorley, to approve as presented, the Resolution to Confirm and Reestablish Speed Limits for the Village of Saranac.

Council reviewed proposed Amendment #1 to the existing Agreement for additional Sheriff's Office services between the Village of Saranac and the County of Ionia.

The proposed Amendment reflects adjustments to the hourly rates paid by the Village for patrol services. The original Agreement, entered into on March 1st, 2015, allows for annual adjustment of the rates based on actual costs, not to exceed 2%.

Actual costs decreased, per the Ionia County Sheriff's Office, thereby decreasing the hourly rate charged to the Village (see proposed Amendment, attached).

Motion was made by Whorley, supported by Mulnix, to accept Amendment #1 to the Agreement between the Village of Saranac and the County of Ionia, effective March 1, 2016, as presented. Roll call vote: yeas – Doll, Klutman, Mackey, Mulnix, Simmons, Whorley, Darby; nays – none; absent – none.

The Zoning Administrator's Report was reviewed.

The Planning Commission did not meet.
