ORDINANCE NO. 106

CONSUMERS ENERGY COMPANY ELECTRIC FRANCHISE ORDINANCE

AN ORDINANCE, granting to CONSUMERS ENERGY COMPANY, its successors and assigns, the right and authority to construct, maintain and commercially use electric lines and related facilities including but not limited to towers, masts, poles, crossarms, guys, wires and transformers on, under, along, and across public places including but not limited to highways, streets, alleys, bridges, and waterways, and to conduct a local electric business in the VILLAGE OF SARANAC, IONIA COUNTY, MICHIGAN, for a period of thirty (30) years.

THE VILLAGE OF SARANAC ORDAINS:

- SECTION 1. GRANT and TERM. The VILLAGE OF SARANAC, IONIA COUNTY, MICHIGAN, hereby grants to Consumers Energy Company, its successors and assigns, hereinafter called "Consumers" the right and authority to construct, maintain and commercially use electric lines and related facilities including but not limited to towers, masts, poles, crossarms, guys, wires and transformers on, under, along, and across public places including but not limited to highways, streets, alleys, bridges, and waterways, and to conduct a local electric business in the VILLAGE OF SARANAC, IONIA COUNTY, MICHIGAN, for a period of (30) thirty years.
- SECTION 2. <u>CONDITIONS</u>. No public place used by Consumers shall be obstructed longer than necessary during construction or repair, and shall be restored to the same order and condition as when work was commenced. All of Consumers' electric lines and related facilities shall be placed as not to unnecessarily interfere with the public's use of public places. Consumers shall have the right to trim or remove trees if necessary, in the conducting of such business.
- SECTION 3. <u>HOLD HARMLESS</u>. Consumers shall save the Village free and harmless from all loss, costs and expense to which it may be subject by reason of the negligent construction and maintenance of the lines and related facilities hereby authorized. In case any action is commenced against the Village on account of the permission herein given, Consumers shall, upon notice, defend the Village and its representatives and hold them harmless from all loss, costs and damage arising out of such negligent construction and maintenance.
- SECTION 4. <u>EXTENSIONS</u>. Consumers shall construct and extend its electric distribution system within said Village, and shall furnish electric service to applicants residing therein in accordance with applicable laws, rules and regulations.
- SECTION 5. <u>FRANCHISE NOT EXCLUSIVE</u>. The rights, power and authority herein granted, are not exclusive.
- SECTION 6. <u>RATES and CONDITIONS</u>. Consumers shall be entitled to provide electric service to the inhabitants of the Village at the rates and pursuant to the conditions as approved by the Michigan Public Service Commission. Such rates and conditions shall be subject to review and change upon petition to the Michigan Public Service Commission.
- SECTION 7. <u>REVOCATION</u>. The franchise granted by this ordinance is subject to revocation upon sixty (60) days written notice by either party. Upon revocation this ordinance shall be considered repealed and of no effect past, present or future.

SECTION 8. <u>MICHIGAN PUBLIC SERVICE COMMISSION JURISDICTION</u>. Consumers remains subject to the reasonable rules and regulations of the Michigan Public Service Commission applicable to electric service in the Village and those rules and regulations preempt any term of any ordinance of the Village to the contrary.

SECTION 9. <u>VACATION OR RELOCATION</u>. The Village may require the Grantee to vacate or relocate any portion of Grantee's facilities at the Grantee's expense if such vacation or relocation is necessary to secure the public health and welfare or is otherwise required by the Village in the exercise of a governmental function.

SECTION 10. <u>COMPLIANCE WITH LAWS</u>. Grantee shall comply with all current laws, statutes, ordinances, rules and regulations regarding the installation, construction, ownership or use of its facilities, whether federal, state, or local.

SECTION 11. <u>REPEALER</u>. This ordinance, when enacted, shall repeal and supersede the provisions of any previous Consumers' electric franchise ordinance adopted by the Village including any amendments.

SECTION 12. EFFECTIVE DATE. This ordinance shall take effect on March 22, 2020.
